EVENT LOCATION: Downtown Mount Clemens, MI

MEDIA: Handmade crafts- paintings, sculptures, pottery, jewelry, fiber, photography, glass, graphics, metal, wood, watercolors, digital, clothing, leather, floral, weaving. NO buy-sell merchandise, commercial products, kits, imports or copies allowed! Artwork must be 85% handmade.

FESTIVAL PROVIDES THE FOLLOWING

- Event Parking Pass – one per vendor
- 2 Vendor Badges

VENDORS MUST SUPPLY THE FOLLOWING

- Tent, chairs, table & skirting
- Power cords (at least 200 ft. of power cord is recommended) or marine battery
- Working hanging lights

TERMS OF CONTRACT FOR ART & CRAFT EXHIBITORS FOR STARS & STRIPES FESTIVAL:

1. ALL PROCEEDS from vendor sales will belong to the vendor. No commissions will be assessed. Vendors are responsible for collecting sales tax and for reporting earnings to the IRS.
2. STORAGE OF MATERIALS during the event must be confined within the area assigned to you. Plan for storage within your area when designing the configuration of your vendor space.
3. VENDORS ARE EXPECTED to provide their own tables, tents and chairs. Do not tape, tack, or otherwise affix any materials or signs to walls, trees, lamp posts or other surfaces on public or private property. Canopies may be anchored by cement, cinder-blocks or sandbags only. No ground stakes are permitted. All booths and their contents must be able to withstand crowds and weather, and fit within a 10' x 12' space. Festival organizers may ask an exhibitor with an unsafe display to correct the problem, or will be asked to leave and forfeit all fees.
4. VENDORS ARE RESPONSIBLE for transporting and placing their own booths. Labor to erect booths will not be provided.
5. NO VENDORS OR THEIR REPRESENTATIVES shall conduct themselves in a manner offensive to general standards of decency or good taste. The Stars & Stripes Festival reserves the right to screen all booths and exclude inappropriate items. In the event of inappropriate behavior, the booth will be forced to close and all fees will be forfeited.
6. WHEN VACATED, vendor space must be left clear of paper, packing materials, or other refuse. Do not discard cartons or packing materials anywhere downtown or in the festival area. These items must be stored in your vehicle and taken with you upon departure.
7. BOOTH SHARING IS NOT PERMITTED. Changing or swapping assigned spaces is prohibited. No exhibitor may sell their assigned space to another craftsperson or share booths with any nonapplicant. Exhibitors may not interfere with adjacent booths in any way.
8. ARTIST IS RESPONSIBLE FOR PROPER INSURANCE.
9. NO TEARING DOWN BEFORE THE SCHEDULED CLOSING TIME. This includes bringing in boxes, packing, or dismantling of displays. This rule is strictly enforced. Failure to abide by this rule could jeopardize your participation in future shows
10. JURY PROCESS- The first batch of applications will be notified of acceptance by April 1, 2011.
