## LOCATION

TJ's Customs Inc. and FunFest Productions are joining forces, presenting the St. Clair Riverfest. Combining annual boat races, a fine art show and Fun Fest Productions expertise in mounting large scale events, the St. Clair Riverfest provides a wide variety of experiences to guests, last year drawing well over 100,000 visitors. The festival takes place in picturesque Downtown St. Clair, on the banks of the beautiful St. Clair River on Riverside Dr. and Palmer Park. The festival will include a fine art show, children's activities, boat activities and live national concerts. Admission to public is free.

## MEDIA

Paintings, sculptures, pottery, jewelry, fiber, photography, glass, graphics, metal, wood and other. All work must be original—no kits, patterns, commercial products or copies allowed. Work not in good taste or not acceptable will be removed by the committee. No dried or silk flowers.

## FEES

\$200.00 per exhibiting art space, plus \$25.00 nonrefundable jury fee (submit separate checks payable in U.S. funds). Upon acceptance, Booth fee is not returnable. Limited corner spaces available for \$35.00, separate check. Electricity will be available for \$35.00. Deadline is April 15th 2008. Late entries will incur a \$25.00 late fee notice of acceptance or rejection will be mailed by May 15th.

## JURING

The jury committee will categorize and view all entries and compile the results. The decisions of the jury are final.

## ARTIST REGULATIONS

- Artists will be assigned their spaces on Thursday, July 25th. Artists must be open and ready to sell by 11 a.m. on Friday, Saturday and Sunday. Artists must remain open until 9 p.m. on Friday and Saturday, and until 7 p.m. on Sunday. NO EXCEPTIONS. Artists must oversee their exhibits at all times and display their work for the duration of the show. Assistants, including family members are welcome, but NOT in place of the artist.
- Cash awards and ribbons will be presented. \$500.00 for best of show, \$250.00 for first place, \$150.00 for second place and \$100.00 for third place and ribbons will be awarded to honorable mentions.
- Submit three 35mm slides representative of your work and one 35mm slide of your entire display or a CD as a jpg file. Artist's name, media and size of work must be clearly printed the front of each slide or CD. Mark "TOP" of each slide.
- Please provide a very brief statement (one paragraph) that describes the materials and techniques used to create your work.
- Booth sharing is not permitted with the exception of collaborating artists. Collaborations must be artistic rather than business. A team producing a single product may qualify as a single exhibitor. However, such a team may consist of no more than two people. If two names are on the application, both artists must sign the application, check in, and show I.D.
- Artists may exhibit their work only in the categories in which they are accepted.
- All booths and their contents must be furnished by the artist, be able to withstand crowds and weather, and fit within a 12'x12' or 24' x 24' space. Festival organizers will ask an exhibitor with an unsafe display to close up and forfeit all fees.
- Only work represented by submitted images can be exhibited. The festival organizers reserve the right to refuse exhibition of work that is not consistent with the artist's submitted images.
- Artists are responsible for collection and reporting of all taxes, including 6% Michigan sales tax.
- Artist is responsible for proper insurance.
- No generators will be permitted.
- Sales of T-shirts and CD's are prohibited.
- Open to all artists 18 years and older.
- No Pets Allowed. No Alcoholic beverages and / or drugs allowed.
