### Restaurant Information And Application

#### WHO MAY PARTICIPATE?

- Applicants must be in good standing with their local Health Departments and have all necessary licenses and permits to operate their business. Copies of such licenses must be included with the application.
- Applicants must be flexible in their choice of menu items for the Festival. The Festival will allow only certain items to be duplicated. All applicants must submit their restaurant menu with their application so that the Festival can facilitate their menu selections.
- Proof of ownership is required. Please do not allow someone to use your name for the weekend.

#### WHAT ARE YOUR OPTIONS FOR PARTICIPATION?

The Festival offers four programs for interested restaurants. The Festival will help you to determine which option best fits your needs. Each of these participants will be **EXPECTED** to be open all hours of the Festival all three days. **Friday, July 25<sup>th</sup> from 12pm – 12am, Saturday, July 26<sup>th</sup> from 11am – 12am, and Sunday, July 27<sup>th</sup> from 11am – 9pm.**

1. Exclusive 10'x10' – one restaurant tent with a 10'x10' outside cooking area. (vendor supplied)  
**PRICE: \$1000**
2. Exclusive 20'x 10' – one restaurant tent (no cooking area). (vendor supplied)  
**PRICE: \$1000**
3. Sharing a 20'x 10' tent with another restaurant with a 10'x10' outside cooking space. (vendor supplied)  
**PRICE: \$800**
4. Exclusive 10'x10' - one restaurant tent (no cooking area). (vendor supplied)  
**PRICE: \$750**

Each restaurant space is sold separately. Restaurant owners and/or restaurant chains that have more than one restaurant participating in the Festival will receive a 25% discount on the second restaurant flat fee. Any restaurant within the city limits of St. Clair will receive a 25% discount.
