WHO MAY PARTICIPATE?

- Applicants must be in good standing with their local Health Departments and have all necessary licenses and permits to operate their business. Copies of such licenses must be included with the application.
- Applicants must be flexible in their choice of menu items for the Festival. The Festival will allow only certain items to be duplicated. All applicants must submit their restaurant menu with their application so that the Festival can facilitate their menu selections.
- Proof of ownership is required. Please do not allow someone to use your name for the weekend.

WHAT ARE YOUR OPTIONS FOR PARTICIPATION?

The Festival offers three options for interested restaurants. The Festival will help you to determine which option best fits your needs. Each of these participants will be **EXPECTED** to be open all hours of the Festival all three days. Friday, June 27th from 11am – 12am, Saturday, June 28th from 11am – 12am, and Sunday, June 29th from 11am – 10pm.

1. Exclusive 10'x10' Space – one restaurant supplied tent (no on-site cooking)
PRICE: \$1,250
2. Exclusive 10'x20' Space – one restaurant supplied 10'x10 tent with a 10'x10' outside cooking area.
PRICE: \$1,500
3. Exclusive 20'x 10' Space – one restaurant supplied tent (no on-site cooking)
PRICE: \$1,500

Each restaurant space is sold separately. Restaurant owners and/or restaurant chains that have more than one restaurant participating in the Festival will receive a 25% discount on the second restaurant flat fee. Any restaurant within the city limits of Mt. Clemens will receive a 25% discount.

FESTIVAL PROVIDES THE FOLLOWING

- Event Parking Pass – one per space
- Restaurant Orientation Meeting (required for all participants)
- General Services: remember we are here to maximize your participation. The Festival will have an on-site electrical contractor and on-site ice sales. Additionally, the Festival will act as a liaison with the Health Department and will provide general consulting to each participant to help choose items, lay out their stands, plan staffing, etc.

VENDORS MUST SUPPLY THE FOLLOWING

- Tent
- One (1) overhead sign listing all menu items, prices and restaurant name
- Tables and skirting
- Chairs
- Power cords and adaptors for electric or generator
- Water hose if water is needed
- Working hanging lights

All applicants must provide an alternate menu item, even if not serving the maximum allowable six items. All prices must include sales tax. **VENDORS ARE NOT ALLOWED TO SELL POP, WATER OR LEMONADE.** BEVERAGES WILL BE MADE AVAILABLE FOR PURCHASE THROUGH FESTIVAL COORDINATORS AT A DISCOUNTED RATE.
