#### **WHO MAY PARTICIPATE?**

- Applicants must be in good standing and have all necessary licenses and permits to operate their business. Copies of such licenses must be included with the application.
- Applicants must be flexible in their items sold at the Festival. The Festival will allow only certain items to be duplicated. All applicants must submit their items with their application so that the Festival can facilitate their selections.
- Proof of ownership is required. Please do not allow someone to use your name for the weekend.

#### **WHAT ARE YOUR OPTIONS FOR PARTICIPATION?**

The Festival offers multiple programs for interested non-restaurant vendors. The Festival will help you to determine which option best fits your needs. Each of these participants will be **EXPECTED** to be open all hours of the Festival all three days. Friday, June 27<sup>th</sup> from 11am – 12am, Saturday, June 28<sup>th</sup> from 11am – 12am, and Sunday, June 29<sup>th</sup> from 11am – 10pm.

1. Exclusive 20'x 10' space – one vendor supplied tent.
2. Exclusive 10'x10' space – one vendor supplied tent.
3. Custom space size is available upon request in advance

Please call for prices. A representative will go over all the options with you to ensure a successful endeavor at our event.

Each non-restaurant vendor space is sold separately. Non-restaurant owners and/or non-restaurant chains that have more than one non-restaurant vendor participating in the Festival will receive a 25% discount on the second flat fee. Any non-restaurant within the city limits of Mt. Clemens will receive a 25% discount.
