### WHO MAY PARTICIPATE?

- Applicants must be in good standing and have all necessary licenses and permits to operate their business. Copies of such licenses must be included with the application.
- Applicants must be flexible in their items sold at the Festival. The Festival will allow only certain items to be duplicated. All applicants must submit their items with their application so that the Festival can facilitate their selections.
- Proof of ownership is required. Please do not allow someone to use your name for the weekend.

### WHAT ARE YOUR OPTIONS FOR PARTICIPATION?

The Festival offers three programs for interested novelty vendors. The Festival will help you to determine which option best fits your needs. Each of these participants will be **EXPECTED** to be open all hours of the Festival all three days. **Friday, June 26<sup>th</sup> from 11am – 12am, Saturday, June 27<sup>th</sup> from 11am – 12am, and Sunday, June 28<sup>th</sup> from 11am – 10pm.**

1. Prime 10' x 10' space – one tent (vendor supplied)
